### Welcome!

Energy efficiency, renewable energy, sustainability, net zero, climate change, global warming, greenhouse gas, etc. We see and hear about these topics every day in the news, on the internet, and on social media. Do you think we as an industry need to do more or do less when it comes to these topics? How do we find a balance when addressing these topics in the world we live in for the "built environment?" This is our profession and industry. We should be the leaders.


How concerned do you think people living in Oklahoma versus California are on these topics? What about people from a small town like Fairview, OK, where I grew up, compared to Los Angeles, CA? Fairview has a population of 2,579 in about four square miles or 645 people per square mile. Once you leave Fairview, you drive through the country and it is a 40-minute drive before you find another town with a larger population. Los Angeles has of population of 3.8 million in about 469 square miles or 27,000 people per square mile. Once you leave Los Angeles, you have a continuum of the population and the more rural countryside can take several hours to reach.

In my opinion, Fairview does not have things like smog. Is that still a term used today? It seems like smog has been abandoned and replaced with more catastrophic terms like global warming and climate change. People in Fairview are not overly concerned about smog because it is not an everyday occurrence or concern. People in Los Angeles on the other hand, have major concerns with smog. It impacts their daily life. They see the smog lingering over their city and are forced to breathe this highly polluted air. The burning of fossils fuels for heating, electric power and transportation all contribute to this smog in their city. It is fair to say that in their minds, fossil fuels are bad, because they contribute so much to the daily smog.

If you drive out to Fairview from Tulsa, you will notice something along the way that did not exist ten years ago, wind turbines. Once you hit the I-35 corridor and head west, the wind turbines are a very

prevalent part of the Oklahoma landscape nowadays. As the Oklahoma song goes, this is where the wind comes sweeping down the plains. Many of the people that live out in western Oklahoma tend to think the wind turbines are bad. Why? It impacts their daily life. They see the wind turbines cluttering their beautiful landscape and in their minds, wind turbines are bad. Natural gas is abundant in western Oklahoma. People favor natural gas for heat and electrical power more than they probably do for wind turbines.





### President's Message, continued

Does it make you wonder, "Where does ASHRAE fit into all of this? Where is he going with this message?" Berkley, CA has recently banned the use of natural gas in all new building permits. The claim is that energy use in buildings accounts for about 25% of the greenhouse gas emissions. If California is to meet its goal of 100% zero-carbon energy by 2045, the use of fossil fuels will have to be replaced with alternate energy sources. This begs the question, is it possible to eliminate the use of fossil fuels for such a dense population? Maybe, but it will bring along other issues like those experienced out in western Oklahoma. They will need more solar panels and wind turbines and more than likely some form of energy storage devices. Californians may be willing to make this sacrifice in order to have clean air.

The northeastern United States is also experiencing a strong push to remove fossil fuels as a source of heat in favor of heat pumps, since they are experiencing the same problem as California. I understand the need to reduce air pollution. Does every city and state in the country need to jump on board with the elimination of fossil fuels for heating? What about the big picture, should we do this globally?

This is where our industry, our country, and our world needs ASHRAE. We need ASHRAE to lead as a professional society for our industry to make sure we have a voice at the table when cities, states, and the federal government make decisions regarding our energy use and the future of energy itself. This especially true in the "built environment." We need to make sure we have a balance in determining what is good for all. ASHRAE will continue to grow globally as the need is the same for the entire world. ASHRAE's Mission Statement is "to serve humanity by advancing the arts and sciences of heating, ventilation, air conditioning, refrigeration and their allied fields." This reflects ASHRAE's desire to lead our industry. ASHRAE's Vision statement is "a healthy and sustainable built environment for all." This ties all of it together. This is why we need to support ASHRAE.



### Chapter History 1990's


As we moved into the 90's, our chapter was meeting at the Candlewood Club. About that time our chapter decided to change method of selecting the editor for the Oil Capital Air and assigned that as a duty to the President-Elect each year. This has been working fine, as we have one of the best newsletters in our region. At CRC, each chapter is graded on different committees such as membership, research, student activities, etc. I'm sure most of you have heard about the PAOE points, which stands for Presidential Award of Excellence. Again, our chapter is one of a few chapters in our region to continually score "Par" in all committees every year. In 1999-00 year our chapter was the only chapter in ASHRAE to achieve the maximum allowed points in all committees. Up to this point in our chapter's history, Chick Morse was the only NEOK president to receive the Golden Gavel Award for his year of 1984-85. It looks like, as we moved into the 90's, the chapter went to work and we brought this award back four more times.

Mary Bowers was close to receiving this award in her year of 1997-98, but that year we hosted the CRC. It is unusual to win this award the year your chapter hosts a CRC, but we were just a fraction of points away from winning anyway. Like I said, our chapter hosted the CRC in 1997-98 at the Doubletree Warren Place. Jack Tumilty and Chick Morse co-chaired this committee and to date I think it is still one of the best, if not the best, CRC meetings held in Region VIII. As I remember, the rest of the chapters in our region did everything they could to top it. This was also the year the Candlewood Club closed down and the chapter moved to the Sheraton Hotel on 41st Street. The year I was president will be a year to remember for me. As we started off the year, our incoming president (Rob Sullivent) was transferred to Texas. I took over as president and about four weeks later my treasurer (Charles Brunner) was transferred out of state (If you are counting we just lost half of the officers). So, we had a good brainstorming meeting and came up with replacements, then finished out the year still achieving the Golden Gavel Award that year (Boy, was I surprised). Of course this is why we have one of the best chapters in ASHRAE, because we have great members and teamwork. Keith Browne jumped right in the next year and won the Golden Gavel again. Jack Tumilty was awarded the Distinguished 50-year Member Award that same year at the annual meeting in Seattle.


moting these scholarships at colleges and high school. If anyone knows any students that would be a good candidate for the scholarships, then direct them to the NEOK ASHRAE website.


